Rental Review

Committees

RE - Marilyn Gaa reported on the RE meeting which took place after Sunday service on September 10, 2017 with 10 or 12 people in attendance. Plans are underway, beginning in November, for a more integrated RE program providing more involvement in Sunday services and with the goal of transitioning youth into church membership. The RE Committee needs to review its role and determine how to best support the program.

Treasurer's Report for September 2017

- The Finance Committee recommends that we hire a payroll company, to start on Jan. 1. Our bookkeeper, Bev Walker, thinks that since she's probably going to be replaced as bookkeeper sometime in the next year (which is true), it would make more sense to wait till she goes.
 My motion: that the board approve contracting a payroll company. Timing to be determined by treasurer.
- 2. Endowment funds are currently at \$80,442, and are in a savings account in Tangerine Bank. The Endowment Committee has decided to invest this money minus \$2,700 in last interest payments on Debenture debt in two GICs.
- 3. Tangerine Bank is an on-line bank that offers higher interest rates than regular banks; however it has no offices and is hard to get info over the phone. To call them, you must have a client number, a personal number, a pin number and a security number. Only Bev right now has access. Bev and I think we should close our Tangerine account and move that money -- \$73,340 in savings and \$80,442 in Endowment money-- into Servus. The goal would be to simplify our complicated financial system for the next treasurer -- my six-year board term ends next spring.
- 4. Bookkeeper: The board asked Bev to count her hours for September, after which we'll decide about changing to an hourly payment. Any new bookkeeper will for sure be paid hourly.

Minister's Report, September, 2017 Brian Kiely

Accomplishments:

EverWonder Conference

Along with several Unitarians I attended the EverWonder Spirituality conference hosted by Southminister-Steinhauer United Church and their minister Nancy Steeves. The keynote presenter was Rev. Gretta Vosper, a self-avowed atheist who has gotten into trouble with many in the United church over her open views. Most Unitarians who have read her books or heard her speak say, "She's one of us." An arguable point, but she has devoted herself to 'irritating the United Church into the 21st Century". It was an excellent conference overall with about 150 in attendance. In this report I want to lift up two points she made that I think are relevant to Unitarians.

1. What do the 'nones' want? This was the main thrust of Gretta's first lecture. Of course, many want nothing 'churchy', but

she argued that what they want in life can be framed as 'religious' values. She used the structure of the four types of prayer: Adoration, Confession, Thanksgiving and Intercessory. She believes the 'nones' correspondingly want to experience awe and connection to something greater (Adoration). They want the opportunity to examine their lives and contemplate self-improvement (Confession). The want to express gratitude for community, health, family, friends, good fortune (Thanksgiving). They want to be able to ask for help in times of need. They want emotional support (Intercessory).

The challenge facing any church is to find ways to offer that but outside a church setting and structure.

2. Her second lecture "Are we dead yet?" addressed the same issues we face here: How do we support our programs and activities in the face of declining revenues and long term loyalty (and giving). We think we are an 'old' church, but in this room of 150 or so people I was definitely one of the youngsters. Her conclusion was partly theological: accept that the world out there is post-Christian and be more welcoming of diverse theologies. It was also partly institutional. Consider the legacy we are able to leave/give to a younger generation and then let them lead with it.

I found the programs useful and largely in line with our issues and ideas. In fact, I think UCE's quiet shift to community meeting place is taking us in the right direction whether all programs fall under our aegis or not.

"The Death of Sunday School" This provocatively titled essay is causing a buzz throughout the UU universe and was the topic of the meeting between Lauren and I and the Westwood professional staff. We also discussed this at the informal Board session on Sunday. The key point in the author's opinion is that the old 'seen but not heard' segregated classroom format no longer fits our world. There is also a good reason to have our children and youth more involved with the Sunday service.

We would like to experiment with the idea. Our plan is NOT fleshed out, for our discussion is not yet a week old. We plan to experiment in November with one change: Have the children in the service for about 40 minutes including the sermon with their families, and then go off to class. Meanwhile the adults complete the service (meditation, closing, announcements) go into coffee hour and then some can attend the Living and Dying Program. We will have a fuller report on the plan next month.

"Living and Dying" Program

Adult Program has received several requests for some programming regarding wills, living wills, assisted dying etc. We are working to find speakers for a variety of sessions:

'Managing post retirement years': Brian

'Talking with family about hard things': Ann Nelson supported by Yvonne Mireau

'Wills and Estate Planning': Lawyer Michael Simons

`Living Wills and assisted dying': Brian supported by Ann Nelson.

We envision the four sessions on successive November Sundays following the service.
