Motion: The Unitarian Church of Edmonton supports the right of all Canadians to a healthy environment, which encompasses rights to:

- (a) an environment that is conducive to health and well being, including: clean air; clean water, safe food:
- (b) have the environment protected, for the benefit of present and future generations, through municipal and legislative measures that: prevent pollution and ecological degradation; and promote conservation.
- (c) access information pertaining to environmental quality and pressures on it.
- (d) participate in informed decision-making that will affect the environment.

We ask the Edmonton City council to sign a declaration recognizing the right to a healthy environment as described above. Further, we ask the City of Edmonton to advocate for legislation at the provincial and federal levels that recognizes this right for all Canadians.

The Unitarian Church of Edmonton moves that we copy an approval of this motion to our City councillor and cc: the Mayor, asking for support.

Hello fellow board members,

We have a late-breaking addition to tomorrow's agenda. The Social Justice Group is seeking input on an initiative. I've included the details below so you have time to consider options before our meeting tomorrow.

#### Context (from Jeff Bisanz):

The Social Justice Group has been considering for a while the idea of encouraging City Council to declare that a healthy environment should be a human right. Today (Sunday, Jan. 7) we decided to consider a motion via email and, if "enough" responses are positive, to bring a suggestion to the Board this Wednesday.\* Marilyn drafted the motion and will present it to the Board. FYI, we have discussed this matter at previous meetings of the Social Justice Working Group and support has always been very strong. Also, the precise wording in the motion probably is not absolutely critical; minor changes could be made without, in my judgment, getting anyone's nose out of joint.

\*Six people had responded to the email by Tuesday evening; all six were responses were positive.

#### Suggested courses of action:

The Social Justice Group has suggested that the following may be courses of action considered by the Board:

- 1. tell the Group to send its own letter to City Council
- 2, tell the Group to send a letter to City Council on behalf of the Board
- 3. tell the Group to send a letter to City Council on behalf of the entire congregation, which may require consideration at the next AGM
- 4. suggest revisions or amendments or some other course of action to the Social Justice Working Group
- 5. discourage the entire idea


#### Proposed motion:

Background information: Over 150 communities across Canada have passed declarations recognizing the right to a healthy environment. These declarations are the first steps in encouraging the Federal Government to enshrine the right to a healthy environment in the Canadian Constitution.

#### Treasurer's report Jan. 2018

- 1. City assessment of our building as of July 2017: \$1, 416,000. Five years earlier, in 2012: \$924,000; in 2013: \$1,029,500. Our taxes will be going up by about \$800 this year, to an estimated \$8,504. And that's just for the front third of our building which isn't exempt from property taxes.
- 2. We have received a cheque for \$12,421 from London Life, which is the amount that Julius Buski put into the insurance plan with UCE as the beneficiary. That will go into our Endowment Fund, which is currently \$88,000 so Endowment is now over \$100,000 for the first time in quite a while. We will use about \$1,000 of that money to pay the interest on our last two debentures next fall. The rest is savings.
- 3. Ruth Merriott is working on getting us ready to use Ceridian as our payroll company starting the end of this month. Janet Polkovsky will do the data entering on this.
- 4. Our financial statements don't fully indicate our situation because the bookkeeper combines contributions from members with money donated to Endowment. Endowment can't be spent on running the church. So, I have created a chart to compare the money (excluding Endowment and Casino money) that we have in the bank as of Dec. 31. As you can see, it is declining, even with our greater rental income. That should guide our major decisions going forward. We have two sub-accounts at Servus, wages and operating, plus a savings account at Tangerine. Susan Ruttan



#### Minister's Report, January, 2018 Brian Kiely

#### **Accomplishments:**

\* Led four services including Blue Christmas and Christmas Eve \* Attended 5 meetings \* Made 11 pastoral care visits or phone calls \* Attended church Christmas party, Set up and worked kitchen for Brundin Memorial.

#### Thinking ahead regarding Religious Education

I have had discussions with Lauren Kay about her still uncertain future. She hopes to decide about her continued employment by April 1 so that she can give three months notice if needed. She is concerned about succession and supporting and possibly training whatever new hire we make. I would suggest that the Board and the HR Committee prepare now for promptly starting a hiring process if necessary. Questions to consider: Does the Board wish to change the contract or workload? What rate of pay can we offer for how many hours? What qualifications will be required? Should we empanel the hiring committee participants in anticipation of a resignation?

#### "The Ethics of Living and Dying"

I have been recruited to be part of an ongoing Southminster-Steinhauer United Church lecture series. The series, now in its second year, brings in speakers from a wide variety of areas. My topic will be as stated in the title. It will be at 7 p.m. on Wednesday, February 7th. There is no charge.

#### Correcting a misconception

I have learned that a rumour was going around concerning my participation in the memorial service for Bob Brundin on January 5th. The concern was raised by a Board member and an HR committee member who received a complaint. I met and discussed the matter directly with the complainant explaining the truth as I knew it. My explanation was fully accepted. I reported back to the two who alerted me as well.

However, it seems like the tale is going around the congregation, though no one else has raised it with me directly.

The story is that I refused to do the service for Bob Brundin saying that I was backing away from such services. I never said or contemplated anything like that. Rites of Passage are a special privilege of ministry. I treasure officiating at those services. I do not know where or why this damaging rumour started. Perhaps it was because in the end, Audrey Brooks led the service.

As it happens, all of my conversations with his daughter Jenny were by email. I am including the full text below. I express clearly both my

Mirister

willingness and enthusiasm for the service. I also (and this is standard in my communications with families) express my willingness to assist the family in whatever way is helpful, including stepping aside. The service, after all, belongs to them. They opted to use Audrey with my full blessing as she is a friend of the widow and because I was too ill to attend church the day they were on hand. To be clear we had no formal appointment set for the day I was ill.

With no other responsibilities, I volunteered to work with Marge Roche in the kitchen. I also set up and struck the chairs in the Sanctuary and helped the family create their memorial display. I happily volunteered because help was needed and because I planned to attend the service.

I would ask you to do whatever you can to dispel this hurtful story if you hear someone discussing it.

#### Hello Brian:

Congratulations on your recent wedding!

This is Jenny Brundin, Bob/Robert Brundin's daughter. Bob died 12/06/17. He loved his association with the Unitarian church (he had a large UU book collection) until he couldn't walk anymore and indicated he might like a memorial service there.

I talked to Janet on Friday and I know the sanctuary is booked the evenings of Jan. 4 and 5 already. She indicated the afternoons were so far free on those days. I forgot to ask her - What is the availability evening/afternoon on January 3 and January 6? (We are hoping to get the answer as soon as we can on that last one as it would entail me changing a plane flight J)

We were thinking of a few songs and readings that my Dad selected (below) and then perhaps we would write a eulogy, have a member of the family play a tune on guitar and/or piano and a poem or two. We are a pretty laid back family. A few questions for you:
