This expenditure must be approved at the AGM next spring and can be paid after that time.

#### 1. Membership confirmation for CUC

Dear Congregational Presidents and Treasurers,

#### **IMPORTANT: Annual Congregational Certification of Membership Request**

Each year in the fall, the Canadian Unitarian Council requests membership figures from congregations. We ask that you provide us with the current number of voting members as of September 1×2018, which will be reflected in your congregation's Annual Program Contribution (APC) for 2019.

This request for membership figures is made in accordance with CUE by-laws, which require that Member Congregations report the number of voting members held by each congregation. This number is determined by your own procedures and by-laws. We strongly encourage you to have a clear and consistent process for establishing this number and that you update it each year.

The membership figure provided will be used to determine how many voting delegates your congregation is entitled to for the Annual General Meeting in May 2019, as well as to calculate the amount of your congregation's Annual Program Contribution (APC).

#### Option for different amount for young adults

In May 2013, a resolution was at the Annual General Meeting passed which gives congregations the option of providing a reduced APC amount of \$35 for Youth or Young Adults members – 35 years of age or under. Congregations can decide if they want to remit this reduced amount for Youth and Young Adult members, or remit the full \$101.60 for all members.

#### Adjustment for Inflation

In May 2018, delegates at the CUC's Annual General meeting passed a resolution to take into account adjustments for inflation. The resolution stated: *The CUC Annual Program Contribution for 2019 is raised in accordance with the 2017 Consumer Price Index fram Statistics Canada by 1.6% from \$100 per member to \$101.60 per member.* 

#### Additional information requested by the CUC's Annual Program Contribution Task Force

The CUC's APC Task Force has been exploring options to the per member method for the APC. One option is a split calculation based on both the number of members and a percentage of donations & investment income used for your congregation's operating budget. We request that you provide information on the following form for analysis by the task force. We also ask that you include the financial statement for the last two fiscal years. The information you share will be used to present a report to the CUC Board and the Annual General Meeting in 2019. Each year, they pay dues to the Canadian UU Religious Educators (CUURE) and to the Liberal Religious Educators' Association (LREDA) in the US. As well, professional events and networking provide rich opportunities for learning and sharing.

CUC staff recommends building respectful and realistic amounts into congregational budgets. In this form, you have the option of including the CUURE membership fee of \$25 in your congregational dues.

Please ensure that the attached Annual Congregation Certification of Membership form is completed and sent back to the CUC office by November 30, 2018. The form must be signed by two elected officers of the congregation and returned to the CUC office in order for your congregation to remain in good standing and to have the entitled number of delegates vote at the Annual Conference and Meeting in May 2019. While it is usual for the president and treasurer sign the certification, other elected members such as the Board Secretary, or Membership Committee Chair, are also able to sign.

#### 2. Request re: Genocide Memorial Service

To: Karen Mills President, Board of Trustees Unitarian Church of Edmonton

Re: Genocide Memorial

In a memo to you dated October 13, the Social Justice Working Group requested that "the Board make the annual Genocide Memorial a function that our church hosts annually." You responded shortly thereafter with three good questions of clarification. The Social Justice Working Group discussed these questions at our meeting on November 11 and agreed to the following responses.

Question1: Are you asking for anything other than physical space (e.g., financial support, promotion on specific channels, providing volunteers or staff)?

We would like the church to undertake the Genocide Memorial Service as part of the church's outreach to the community and to include the service as a regular part of the summer schedule (see Question 2 below). This special service would be promoted as any other service might be promoted. The Service would be organized by the Social Justice Working Group in collaboration with the Edmonton Interfaith Centre and possibly other groups. No special financial requirements or requests are anticipated.

Question 2: Are you looking to have a consistent date each year (e.g., the second Sunday of July) or is the timing flexible?

Because some of the groups involved plan their participation months in advance, it is important that the annual Genocide Memorial Service be scheduled consistently from year to year. In past years it has taken place on the third Sunday of July. We would like that day to be reserved for the Genocide Memorial Service in future years.

Question 3: Are there thoughts of moving the garden and stones that are currently in Audrey's yard to the church?

After discussing advantages and disadvantages to moving the memorial garden and stones, we agreed that the memorials should remain in Audrey's yard for the present. Joel Brooks, Audrey's son, confirmed that the family can maintain the memorials there.

I hope these responses are satisfactory. If you have any additional questions, please let me know.

#### 5. Proposals re: undocumented individuals

## **Proposal 1** to the board of the Unitarian Church of Edmonton

Re: Sanctuary space needed for undocumented individuals and families in Edmonton

There are a growing number of undocumented individuals and families in Edmonton, with estimates in the tens of thousands. Many of these individuals are denied refugee claimants, past temporary foreign workers, past live-in caregivers, and past seasonal agricultural workers. There is a need to find spaces of sanctuary to support these individuals. We have tried finding a safe space to bring some of these individuals and families together to support each other while discussing their needs or concerns. We tried to do this at a classroom at the University of Alberta on a Sunday, but a peace officer entered the room, terrifying (unintentionally) all the people present.

Stories of undocumented individuals and families in Edmonton were shared to the congregation on Sunday October 28<sup>th</sup> based on the October theme of "What would it mean to be a people of sanctuary?". After the gathering, several members came up to me requesting that I put a proposal to the board for the Unitarian space to become a sanctuary space for these struggling families.

#### Request: The Unitarian Church of Edmonton to become a sanctuary space

A sanctuary space would be a safe supportive space for families to gather to support each other, perhaps once a month. It would be a space where families would not feel scared of authorities finding them to deport them.

I would be happy to do a full presentation to the board about the circumstances of undocumented individuals in Edmonton if this would be helpful.

## Proposal 2 to the board of the Unitarian Church of Edmonton

*Re: the undocumented pregnant woman spoken about on the Sunday service of October 28<sup>th</sup>* 

Claire (pseudonym) came to Canada to work as a live-in caregiver and was not able to gain permanent residency. She is undocumented in Edmonton with the pressure to financially support her family back home.

Claire's current circumstance:

- She is pregnant with no support from her family or the father of the child
- she has no ability to pay for the medical costs of her delivery (approximately 8000 CAD if in hospital or 2000 CAD for a midwife). Her first born child was born by emergency caesarian, which is causing her anxiety about the costs associated with this birth if this child will result in the same situation).

Request of the Unitarian Church:

- have a special collection to be taken for Claire's medical costs of delivery
- funds to be held:
  - o by the church in a special fund,
  - o by Migrante-Alberta (the organization supporting her), or
  - o given directly to Claire

Claire was raised Catholic, but it has been difficult reaching out to the Catholic church because of her precarious status many label as 'illegal' or 'criminal'. However, we are continuing to try to reach out to different Catholic churches.

#### 7. Special appeal for the Adam family

Rev. Anne Barker & Rev. Brian Kiely November 5, 2018

To: The Boards of Trustees at Westwood Unitarian Congregation & The Unitarian Church of Edmonton

Dear Board friends,

We are writing, together, in need of your help. The Adam family are currently under extreme stress, and are reaching out to us – as we, the two churches, are really their only resources in Edmonton.

For quite a few months, they were doing well. Mohamed acquired work with a reputable painting company, and has been supporting his family. Ramza has been attending sewing classes through Islamic Family Services, and is registered for level two English with Access. This independence means a great deal to them, and they are very proud of their achievements. They moved into a new rental location (without the fourth floor walk- up), and were establishing themselves quite happily.

Unfortunately, there is little work right now, and their income is insufficient to cover their needs. We have inquired with Mohamed's employer – and there is no problem. In fact, he is one of only two workers that were retained, when the summer crew was laid off. The employer is happy with his work, but business is currently slow, with many delays. And Ramza's training is a long way from employment readiness.

Mohamed requested our help to find supplementary work. Enquiries have been made, but without any leads so far. He would eventually like to manage his own business, but that is premature. The need for better language skills, and financing, currently make this too complicated. Right now, he is actively trying to find extra work, and hoping for his primary work to pick up. We have been running notices at both congregations – in case folks have painting jobs that need doing – without much response.

The family is now very close to housing insecurity, and struggled to afford food for the past two months. We (Anne & Brian) have both provided supplementary relief – but don't have the resources to make much difference. We are at a loss to solve this problem, and the family is not sufficiently equipped to weather this storm on their own.

Together, we are requesting that the two Edmonton congregations put out a special appeal – requesting donations to aid the Adam family through this insecure season. Details can be worked out; today we are primarily asking for your permission to send out a request for assistance. We (Brian & Anne) could manage the donations, using an allied response – or a task force could be created, and a fund could be established – but the situation is too urgent to wait for a long process to ensue. The need is immediate, and we have no idea how long it will last. While we all wish they were more self-sufficient by now, they clearly aren't – and are doing the best they are able, with the limitations they experience.

They have not asked for this appeal. They are proud, and want to be working. But they are also desperate. We have no work to offer them and we have exhausted our personal connections in an attempt to help make work possible.

May we have your permission to make a joint appeal from the two congregations?

#### The work of next year

As we discussed at the Board work session last Saturday, in 2019 I will be giving special focus to items that will be necessary to help the congregation manage the ministerial transition time:

1. Restarting and rebuilding Congregational Services. This will include training service leaders, working with the revitalized committee to develop methods and practices for planning Sunday services, have the consider budget planning for guest speakers, etc.

2. Continue to work with Erica DeNeve to develop the congregational companions model of pastoral care as well as ensuring other methods of identifying need and delivering pastoral care are available for the congregation.

3. Identify the need for a Lay Chaplain, recruit someone for training if that seems appropriate snd develop a support team to assist during the transition time.

Overall, 2019 will be focused on delivering services (Sunday, program and administrative) at a high level and facilitating the preparation of the congregation's infrastructure for the time after my departure. I have no intention of influencing what happens after I step down. That is not appropriate, nor is it my desire. Instead, I want to ensure that the systems that will allow the congregation to manage its own activities are restored or built afresh. I will happily take the Board's advice on which areas need attention throughout the year.

#### Western Region Fall Gathering 2020

Despite requests, I do not believe that Joan Carolyn of the CUC has yet asked for an invitation from the Edmonton congregations to host WFRG 2020. That said, since we are fully expecting one, the Westwood Board has already approved their end of the invitation. It will be our turn in the rotation and a chance to show off. It is a wonderful event attracting about 60 people from across the west and about 40 youth.


