NEW BUSINESS

Food Bank

Mike Keast and Rev. Rosemary will be meeting with Food Bank representatives in January with a view to re-establishing a food bank depot at UCE, with COVID protocols as necessary.

Audit Report

The audit report dated Dec 10, 2021, prepared by Larry Charach and Ruth Merriott was reviewed. The report will be presented at the AGM in May 2022.

West Trust Grant Update

UCE has been approved for \$1,500 for a projector, which is roughly half the cost. Audrey Brooks suggested fundraising possibilities to cover the remainder of the cost of the projector.

Mike Keast noted that UCE is applying for a provincial government re-opening grant available for those participating in the Restrictions Exemption Program.

Copyright Issue

A letter was received from a Toronto law firm (attached) demanding payment as a result of UCE having posted copyrighted photos on the website. The photos were included with a past sermon by Brian Kiely, and have been removed. Rev. Rosemary advised that all former minister Brian Kiely's sermon's will shortly be removed from the website, as that is the common practice.

A letter had been received sometime earlier from the law firm's client, however it was decided to ignore the request for payment at that time. There was some question as to whether the letter is authentic and not the work of scammers. Gloria Krenbrenk will speak to the Toronto law firm by phone prior to any further action, and to ensure that the letter is authentic.

Noting the December 17, 2021 deadline if we choose to pay the discounted amount (\$2,400), it was **Moved** by Marilyn Gaa, **seconded** by Jennifer Askey, that assuming the request is legitimate, UCE pay the required discounted amount of \$2,400 by December 17, 2021. **CARRIED.** Susan Ruttan will locate a suitable lawyer.

NOTE: Gloria Krenbrenk spoke to Lawrence Veregin, assistant to the lawyer Kenneth R. Clark, by phone on December 16, 2021 and confirmed that the letter is authentic. Mr. Veregin granted an extension of time to **January 31, 2022**, to pay the discounted amount of \$2,400 (email attached).













Leases vs Utilities and Taxes

Report for the Board Unitarian Church of Edmonton

For the month of November 2021

1. Worship and Rites of Passage

- Designed and led two services in November .
- Bringing new service leaders into the mix. Gordon Ritchie is scheduling them, and together we are training (on the job) and getting folks used to taking a lead role in the service. Next step is to have service leaders bring a reading, poem, or reflection on the topic to the service planning.

2. Pastoral Care and Presence

• A few congregants have reached out to me for pastoral care. I have assisted one congregant in particular with food and provided three additional pastoral care sessions with congregants this month.

3. Spiritual Development for Self and Others

 I continue with my own spiritual practice and I had a session with my spiritual director on November 23rd.

4. Social Justice in the Public Square

- November was a big month for social justice. The social justice working group
 provided a wonderful speaker and service. I was glad I was there and had an
 opportunity to meet and connect with Chantal the social justice speaker.
- I provided a few opportunities in November for people to begin to understand the depth and necessity for the adoption of the 8th Principle. I was very pleased that the congregation voted overwhelmingly in favour of having our delegates vote 'yes' in the CUC special meeting.

5. Administration

- Janet and I continue to meet regularly (3x minimum per week) and we continue to clarify things regarding communication, additional duties, systems and processes.
- The three staff members had a staff lunch together the last Friday of November.
 This was a great opportunity for us to connect, and have relaxed general conversation. More importantly, we were able to share what each of us is doing to support UCE. We came away from this lunch feeling much more like a cohesive staff, working together to help systems flow and feeling proud of our support to UCE.

6. Serves the Larger Unitarian Universalist Faith

- Met with Wood Buffalo cluster on November 25th.
- Met with Interim Ministry colleagues in November (Formerly my ARAOM working group)
- I meet monthly with my Preliminary Fellowship mentor (Joanne Giannino)
- I attended the Interim Ministry Network's annual conference. This weeklong event was held the first week in November. This was an ecumenical and multi-faith function. I learned a lot and came away with some great resources.
- The second and third weeks in November I took a course entitled: Fundamentals of Transitional Ministry: The Work of the Congregation. Again, the learning was exponential. This course was second in a series of two, I took the first one in August of 2018. Next, I will be doing a project in order to reach my goal of a designation of Accredited Interim Minister. (I'm an Accredited Interim Minister – In Training right now)
- UCE took part in the National Service and special meeting the weekend of November 28th. We had good participation from our members at the National Service on Sunday, November 28th.
- During November, Mike Keast, Susan Ruttan, Yvonne Mireau and myself met with Joan Carolyn to begin planning a startup workshop to be held January 22nd. This workshop with help us with setting goals for our congregation.

7. Leads the Faith into the Future

 Registration for in person General Assembly just opened. I would love to see a few folks from UCE go to GA. The connections and learning that happen at a GA are brought back to the church – this can be a catalyst for moving energetically into the future.

General Comments for November, 2021

I was very pleased the adoption of the 8th Principle was carried. This action can now be our grounding for anti-racism and justice work within the congregation and into the larger community. I believe that UCE will be energized by working with partners in the greater Edmonton area. I am looking at making connections and will bring news of that to January's meeting.

[sneak peak] Mike and I are meeting with the Edmonton Food bank the first week in January. UCE will get back to being a depot shortly afterward.
