


Income Tracking

Report for the Board Unitarian Church of Edmonton

Rev. Rosemary Morrison For the month of April 2022

1. Worship and Rites of Passage

• Designed and led four services in April. Three regular Sunday morning services and a memorial service for Bryce Missell with Rev. Brian Kiely.

2. Pastoral Care and Presence

• I had four pastoral care sessions this month.

3. Spiritual Development for Self and Others

- I continue with my own spiritual practice and I had a session with my spiritual director on April 21st
- Participating in a 'Circles of Trust' group with other UU ministers. This is a time of deep sharing, sacred listening, and learning to ask open, honest questions of one another.
 This is based on Parker Palmer's work and is being led by a minister trained and certified by Parker Palmer's Center of Courage and Renewal

4. Social Justice in the Public Square

- The food bank depot is up and running. We have partnered with Ali
 Hammington's initiative and all of our left over perishable food goes to her group
 to help with the Thursday dinner put on in the Norwood community.
- Started a book group. On April 17th e read and discussed *Five Little Indians* by Michelle Goode. The book group is now called: The UU Open Hearts Book Club and is open to all Edmonton Unitarians (and beyond). We have decided to continue to read books that will educate us regarding Residential School Syndrome and the effects of colonization. The next few books are: *An Indian in the Cabinet: Speaking Truth to Power* by Jody Wilson-Raybould. After that: *Indian Horse* by Richard Wagamese and *The Inconvenient Indian: A Curious Account of Native People in North America* by Thomas King.

5. Administration

- Hold monthly staff meetings with all staff members. Weekly check in with Maria Jenkins, in person weekly with Oksana Atwood, and every work day check in with Janet Polkovsky.
- Attended four committee/team meetings and board meeting.
- Added May 26, 2022 Together with the Governance Implementation Team I am leading a process to engage the congregation in creating a Mission and Vision Statement along with a Covenant of Right Relations. This process began with the

congregation in April and will conclude in June when I will bring a draft Mission and Vision statement to the congregation.

6. Serves the Larger Unitarian Universalist Faith

- I meet monthly with my Preliminary Fellowship mentor (Joanne Giannino)
- I met with the cohort created after taking the Foundations of Transitional Leadership: The work of the congregation. We met on April 7th for the last time and I have received my certificate (attached).
- I am on the planning committee for the next Interim Ministry Network Conference. I am learning a lot from my colleagues of different faiths. (Ongoing)
- Attended the Wood Buffalo UU ministerial cluster on April 28th
- Monthly meeting with all Edmonton UU religious professionals on April 7th. (Rev. Anne Barker, Rev. Rosemary Morrison, Oksana Atwood, and Ilara Stefaniuk-Gaudet)

7. Leads the Faith into the Future

 Took part in 'Widening the Circle of Concern – Canadian Edition.' This four part series for Canadian UUs is to bring us to a deeper awareness and understanding of how to live into our 8th Principle. The idea was to have a conversation group to discuss the issues brought forward in the presentations and discussion. I was unable to find folks willing to do this with me.
